MEMBERSHIP

Your NNSC monthly club fee covers your membership and insurance to Swim England, pool hire, lifeguarding costs, training costs of the coaches, managers and other club expenses. The time given by the coaches, officials and committee members are solely voluntary. Your monthly club fee also includes the swimming category you are applying for below. Please tick as appropriate:

- Category 1 training plus league/trophy gala swimmers: **£24 per month**
- Category 2 as above plus open meets: **£25.50 per month aged 9 years and above**
- Category 3 adult poolside helpers: **£1.50 - £11** annual voluntary contribution

IMPORTANT: Swim England Annual Membership And Insurance is calculated into monthly instalments and added to your monthly club fee for financial ease. If you wish to terminate membership, please submit a dated letter in writing giving one months notice. This will enable the club to calculate the outstanding remainder of your Swim England membership and insurance which is payable to them upon departure.

Other Information

Occasionally NNSC may take photos for use in the club newsletter, website or for general publicity purposes. Your child may be videoed to help them improve their swimming technique. Please tick box if you **do not** wish your child to be photographed/videoed.

Data Protection Act 1998

The Data Protection Act 1998 ("the Act") sets out certain requirements for the protection of your personal information (i.e. Information about you), against unauthorised use or disclosure. The act also gives you certain rights. The club holds information on members and is asked to submit extracts of this information to the Swim England. Please read the British Swimming/ Swim England Data Protection notice on the club website (www.northernsc.co.uk) as by signing this form you are agreeing to this data being held and supplied to the Swim England where necessary.

Details relating to disclosure of disabilities and medical conditions and medication taken are not covered by the Data Protection Act. Hence Nottingham Northern Swimming Club agree that only relevant club members (e.g. Head Coach, Lane Coaches, team managers, Welfare Officers) will be made aware of any disability or medication your child/children are receiving. By signing this form you are consenting to this information being made available to these members.
